WE HYMAN ZELINSKY of 21 West Arbour Street  
Stepney in the County of London Tailor, YESHUYA  
ZELINSKY of 53, Turner Street, Commercial Road E.1.  
in the County of London, Retired Baker, JACOB  
PSHEDETSKY of 6, Edward Street, Mile End in the  
County of London, Tailor HEREBY JOINTLY AND  
SEVERALLY make Oath and say as follows :-

1. AND FIRST, I the said HYMAN ZELINSKY  
make Oath and say as follows :-

2. THAT I am informed and believe that  
Certificates of Birth are not officially issued in  
the District in which I was born.

3. THAT I am informed and believe that I  
was born ~~1~~ on the 19th day of March 1876 (22nd of  
Adar - 5636, Jewish Date) at Psheich Russian  
Poland

4. AND I THE SAID YESHUYA ZELINSKY make Oath  
and say as follows :-

5. THAT I was well acquainted with  
ISRAEL ZELINSKY the Father of the above-named Hyman  
Zelinsky.

6. THAT I am the Brother of the said Israel  
Zelinsky.

7. THAT I was present at the Marriage Ceremony of my Brother the said ISRAEL ZELINSKY with one ~~LEBER~~ NIEHAUS.

8. THAT they were Married at Pscheich, Russian Poland on the 6th day of January 1867.

9. THAT I knew and was well acquainted with the Family of my Brother Israel Zelinsky after Marriage.

10. THAT I continued to live in the same Town of Pscheich and I was present at the *Circumcision* Ceremonial on the 26th day of March, 1876 (first of Nissan, 5636, Jewish Date) which took place in accordance with Jewish <sup>rites</sup> ~~rights~~ and customs seven days after the Birth of the said HYMAN ZELINSKY.

11. THAT to my knowledge the said Hyman Zelin sky was Born in the said Town of Pscheich on the 19th day of March 1876.

12. AND I THE SAID JACOB PSHEDETSKY make Oath and say as follows :-

13. THAT for a period of about four years from about the year 1874 to 1878 I was employed by the said Israel Zelinsky, Father of the said Hyman Zelinsky in the Town of Pscheich aforesaid.

14. THAT I remember the Birth of the said Hyman Zelinsky and I was present at the *Circumcision* Ceremonial on the 26th day of March 1876 (first of Nissan 5636, Jewish Date) which took place in the said Town of Pscheich aforesaid.


