ceed Rabbi Dr Norman Solomon who has resigned, but who is continuing to serve until January 1, 1972, when Dr Simons takes over.

Born in Edgware, Middlesex, Rabbi Dr Simons received his education at Carmel College, London University and at yeshivot in Israel. He has been headmaster of the Edgware Adath Yisroel Hebrew classes and, before joining the new Jewish settlement at Hebron — of whose religious council he is chairman — he was a lecturer in chemistry at Bar-Ilan University.

On behalf of the King David  
 Foundation I offer to Rabbi C. Simons  
 the post of Head of the Department of  
 Jewish Studies for a period of 3 years  
 at an annual salary of £3000 a year  
 and then terminable by at least one  
 term's notice on either side. The

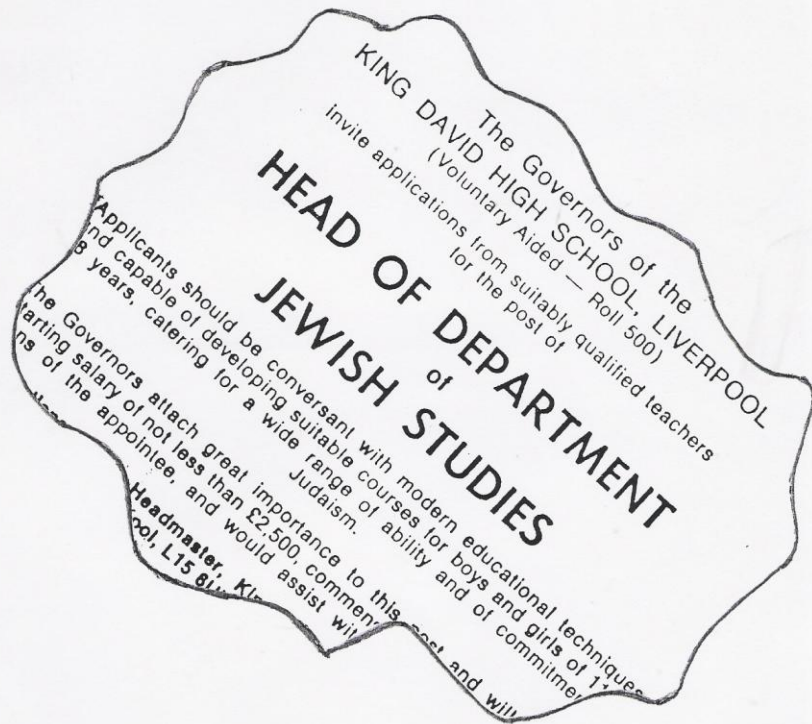
